NOTICE IS HEREBY GIVEN, that the Annual Budget Hearing of the Holland Central School District will be held in the Jr./Sr. High School Library, 103 Canada Street, Holland, New York in said District on Monday evening, May 7, 2018 at 6:00 p.m. prevailing time, for the purpose of presenting the school budget and any propositions as adopted by the Board of Education for the fiscal year July 1, 2018 through June 30, 2019 and for the transaction of such other business as is authorized by law.

AND NOTICE IS ALSO GIVEN, that the Annual School District Vote of the Holland Central School District will be held on Tuesday, May 15, 2018 from 6:00 a.m. to 9:00 p.m. prevailing time in the Jr./Sr. High School Gymnasium, 103 Canada Street, Holland, New York for the purpose of adopting the school budget for the fiscal year July 1, 2018 through June 30, 2019, for the purpose of approving the following propositions and for the election of two at-large members to the Board of Education, and for the transaction of such other business as is authorized by law.

PROPOSITION NO. 1

Shall the following proposition be adopted to wit:

RESOLVED, that the budget for the Holland Central School District for the fiscal year commencing July 1, 2018 and ending June 30, 2019, as presented by the Board of Education be hereby approved and adopted, and the required funds be hereby appropriated, and the necessary real property taxes be levied on the taxable property in said district to be collected as required by law.

PROPOSITION NO. 2 PURCHASE OF TRANSPORTATION VEHICLES

Shall the following proposition be adopted to wit:

RESOLVED, that the Board of Education of the Holland Central School District (the "District") is hereby authorized to acquire two (2) sixty-six passenger buses at an estimated maximum cost of \$112,295 each, at an estimated maximum aggregate cost of \$224,590 less trade-in value, if any, and that such sum (or so much thereof as may be necessary) shall be raised by the levy of a tax to be collected in annual installments, with such tax to be partially offset by state aid available therefore; and, in anticipation of such tax, obligations of the school district (including, without limitation, bonds, notes or lease/purchase or installment purchase obligations having a term of not more than five years) shall be issued.

NOTICE IS ALSO GIVEN, that petitions nominating candidates for the office of two members of the Board of Education shall be filed in the office of the Clerk of the School District between the hours of 7:30 a.m. and 3:30 p.m., prevailing time, not later than 3:30 p.m. on Monday, April 16, 2018 that being the 30th day preceding said election. The following vacancies are to be filled on the Board of Education by reason of expiration or resignation on June 30, 2018:

Two (2) At-Large Five Year Terms to 6/30/2023

Last Incumbents - Jenelle Nadler and Brian Jones

Each petition shall be directed to the Clerk of the School District, shall be signed by at least twenty-five (25) qualified voters of the District and shall state the name and residence of each candidate. Petition forms may be obtained from the Clerk of the School District in the District Office beginning March 12, 2018 between the hours of 7:30 a.m. and 3:30 p.m.

NOTICE IS ALSO GIVEN, that voting machines, provided by the Board of Elections, will be used to record the vote on the budget, on all propositions, and on the election of two at-large members of the Board of Education. Absentee ballot applications will also be available by contacting the Clerk of the School District between the hours of 7:30 a.m. and 3:30 p.m. Proof of residency is required in order to obtain a ballot. Such form may include a driver's license, a non-driver identification card, a utility bill, or a voter registration card to be submitted with a completed application. Applications will be available beginning on April 2, 2018. Completed ballots must be received by the District Clerk not later than 5:00 p.m. prevailing time on Tuesday, May 15, 2018. A list of persons to whom absentee ballots are issued will be available for inspection to qualified voters in the office of the District Clerk. Any qualified voter present in the polling place may object to the voting of the ballot upon appropriate grounds for making his/her challenge and the reasons therefore known to the Inspector of Elections before the close of the polls.

NOTICE IS ALSO GIVEN, that District residents may obtain a copy of the budget at any schoolhouse in the District, during designated hours, on each day other than a Saturday, Sunday or holiday, during the fourteen days preceding the date of the annual meeting and election between the hours of 7:30 a.m. and 3:30 p.m. beginning on May 1, 2018.

AND FURTHER NOTICE IS HEREBY GIVEN, that the qualified voters of the Holland Central School District shall be entitled to vote at said annual vote and election. A qualified voter is one who is (1) a citizen of the United States of America, (2) eighteen years of age or older, and (3) resident within the Holland Central School District for a period of thirty (30) days next preceding the annual vote and election. The Holland Central School District shall require all persons offering to vote at the budget vote and election to provide one form of proof of residency pursuant to Education Law 2018 – c. Such form may include a driver's license, a non-driver identification card, a utility bill, or a voter registration card. Upon offer of proof of residency, the Holland Central School District shall also require all persons offering to vote to provide their signature, printed name and address.
